
Your data will be collected through the respective forms that we send you by email or that you download yourself from our corresponding links on our website https://www.tierfreunde-lesbos.de and send to us by email or letter with your data filled in and signed.

Your data will be used exclusively for the purpose of the selected form. It will not be merged with data from any other source.

If it is necessary for the processing of the work according to the attached form, we will pass on your data exclusively to the person(s) entrusted with the further processing and completion.

For example: We cannot carry out preliminary checks for placements nationwide ourselves, therefore preliminary checks are occasionally carried out by animal welfare colleagues from other associations. They then also sign a corresponding data protection form regarding your data.

You have the right to receive information about the recipients and purpose of your stored personal data free of charge at any time. You also have the right to demand the correction, blocking or deletion of this data.



For some data there is a legally prescribed retention period. Here the <u>legal regulation</u> shall take precedence. We will then delete your data immediately after the deadline has <u>expired</u>.

Tierfreunde Lesbos e.V. takes the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the legal data protection regulations - DSGVO - as well as this privacy policy. Many data processing operations are only possible with your express consent. You can revoke consent you have already given at any time. For this purpose, an informal communication by e-mail to us is sufficient. The legality of the data processing carried out until the revocation remains unaffected by the revocation. Deletion due to revocation is always possible within the framework of the statutory retention periods.

In the event of violations of data protection law, the person concerned has the right to lodge a complaint with the competent supervisory authority.
